SHIFT CHANGE:

Our guards work twelve hour shifts and shift change is at 06h00 and 18h00. Guards are transported to and from their place of work with company transport to ensure that they are in time for work, dressed and equipped according to Company standards and client requirements.

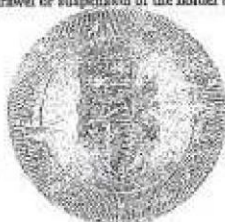

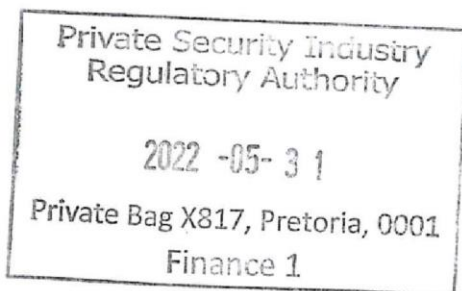

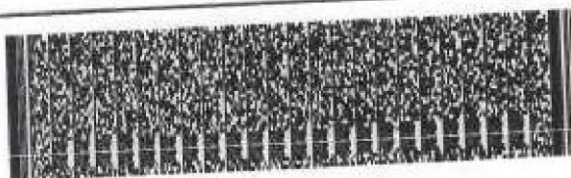
